

## MEMORANDUM OF UNDERSTANDING

MEMORANDUM OF UNDERSTANDING/AGREEMENT BETWEEN THE STATE OF NEBRASKA/NEBRASKA EMERGENCY MANAGEMENT AGENCY AND LOCAL GOVERNMENT DBA/EAST CENTRAL COMMO REGION IN NEBRASKA, INVOLVING STATE USE OF HOMELAND SECURITY GRANT FUNDING REGARDING LOCAL GOVERNMENT

1. PARTIES. The parties to this Agreement are the State of Nebraska/ Nebraska Emergency Management Agency and the Local Government, dba/East Central PET/Commo Region in Nebraska.
2. AUTHORITY. This Agreement is authorized under the provisions of the United States Department of Homeland Security issued **Public Safety Interoperable Communications (PSIC) Grant # 2007-GS-H7-0050**.
3. PURPOSE. The purpose of this Agreement is to set forth terms by which Nebraska shall expend 2007 PSIC funds on behalf of Local Government. On September 30, 2007 the United States Department of Homeland Security issued grant number **2007-GS-H7-0050** to Nebraska. Under this grant, Nebraska must allocate grant funding to Local Government. Under this grant, Local Government may authorize Nebraska to utilize funds on behalf of Local Government, provided that Local Government and Nebraska enter into an Agreement on the matter.
  - a. The purpose of this agreement is to set forth terms by which the NEMA shall enter into a contract utilizing PSIC Grant funds allocated to the East Central PET/Commo Region in Nebraska. The Contract will be for:

### RESPONSIBILITIES.

- b. State
  - i. NEMA will provide staff for contract over-site, administration of 2007 PSIC funds in the amount of \$ 241,775:
    - a. \$185,775 to support Investment Justification #3 "Regional PSAP Interconnectivity" at a Regional level within Nebraska (The \$185,775 is the balance of E. Central's IJ #3 after deducting \$21,250 previously MOU'd back to the State for planning activities).
    - b. \$56,000 to support Investment Justification #4 "Mutual Aid Frequency Overlay" at a Regional level within Nebraska.

5. OTHER PROVISIONS. Nothing in this Agreement is intended to conflict with current laws or regulations of Nebraska or Local Government. If a term of this agreement is inconsistent with such authority, then that term shall be invalid, but the remaining terms and conditions of this agreement shall remain in full force and effect.
6. EFFECTIVE DATE. The terms of this agreement will become effective on the most recent date on signature lines below.
7. MODIFICATION. This agreement may be modified upon the mutual written consent of the parties.
8. TERMINATION. The terms of this agreement, as modified with the consent of both parties will remain in effect until July 31, 2012. Either party upon 10 days written notice of the other party may terminate this agreement.
