Ray Richards moved to approve the minutes. Pat Foust seconded the motion; the motion passed by voice vote.

Discussion Items

1. Introduction of Contractor for Regional Interoperability Network

The contract stage is currently in process for the Regional Interoperability Network. Meeting with the contractor is delayed pending the completion of the contract. NCOR Members will review the contract plan for project completion and approval for the Panhandle portion of the project. The tower surveys are complete, so the tower information will be ready to share with the contractor. OCIO provided 14 structural analyses of the towers and a review of the trunk system. Each region must designate a point of contact, who will have knowledge of alternate tower availability, serve as a contact for the contractor throughout the project, and meet for project-based concerns with an assigned Point of Contact Committee. If the Point of Contact is different than the NCOR representative, the region must inform Rod Hutt of NEMA.

Staging will be an important part of the process. NEMA will oversee design review and project implementation. NEMA will support Mutual Aid design and coverage. NEMA will work with the regions for sharing and redundancy.

It is expected that grant money that was MOU'd to the state will be used for the completion of the project. Some funds will come from PSIC grant money, which requires an environmental review for most projects.

2. Mutual Aid Project progress

Product expenses for the radio vendor and the state contract pricing were compared. The state contract pricing was not found to be more expensive that other radio vendors. The state contract pricing includes hardware only, not installation and maintenance.

The SOP Workshop held June 23-24, 2010 with the Office of Emergency Communications from the Department of Homeland Security was helpful in working to create SOPs for Mutual Aid. It is important to maintain compatibility with the local areas and the state patrol in regards to planning for VHF and UHF. Guidance for compatibility must come from the State Patrol on 800 megahertz. Experience with Paraclete has led to a conclusion that it is not always reliable when using digital radios. Some of the Paraclete issue appears to be related to use of the trunked system. A small group volunteered to review the existing issues with the system and report back in 1-2 months. The group includes: Mark Conrey, Pat Gerdes, Steve Cass, Mike Jeffres, Tim Hofbauer, Bob Eastwood, Jim Gerweck, and Rod Hutt.
