MINUTES – Regular Meeting

Call to Order

Chairman J. Renee Critser called the regular meeting of the Southeast Regional Emergency
Management Governance Board to order at 10:05 a.m. on August 3, 2017 at the Gage County EOC, Beatrice,

Approval of Agenda

Motion was made by Jefferson/Saline, seconded by Otoe to approve the July 6, 2017 agenda as presented with no corrections or additions. Motion was approved by all present.

Discussion of MOU of 2015 NRIN monitoring money

Motion was made by Johnson/Pawnee, seconded by Jefferson/Saline to MOU the \$35,000 set aside for NRIN monitoring from the 2016 grant period back to NEMA for the build out of NRIN equipment in the Southeast Region. Voting aye were Johnson/Pawnee, Richardson, Jefferson/Saline, Lancaster, Seward/York, Fillmore, Otoe, Nemaha and Gage; voting nay were none. Motion passed.

Funding Requests & Claims – Pickeral Tower

Motion was made by Johnson/Pawnee, seconded by Otoe to approve the funding request for Gage County, Pickrell Water Tower in-lieu-of-rent for electricity for the NRIN project in the amount of \$500.00 out of the FY2016 grant. Voting aye were Nemaha, Otoe, Fillmore, Seward/York, Lancaster, Jefferson/Saline, Richardson and Johnson/Pawnee; voting nay were none; Gage abstained. Motion passed

Funding Requests & Claims – Wymore Tower

Motion was made by Jefferson/Saline, seconded by Otoe to approve the funding request for Gage County, Lower Big Blue Water Tower in Wymore, NE in-lieu-of-rent for electricity for the NRIN project in the amount of \$500.00 out of the FY2016 grant. Voting aye were Johnson/Pawnee, Richardson, Jefferson/Saline, Lancaster, Seward/York, Fillmore, Otoe and Nemaha; voting nay were none; Gage abstained. Motion passed.

Funding Requests & Claims – Regional Workshop

Motion was made by Johnson/Pawnee, seconded by Fillmore to approve the funding request for the Southeast Region, Educational and information sharing workshop for the PET group not to exceed the amount of \$3000.00 total out of the FY2016 grant. Voting aye were Gage, Nemaha, Otoe, Fillmore, Seward/York, Lancaster, Jefferson/Saline, Richardson and Johnson/Pawnee; voting nay were none. Motion passed.

Funding Requests & Claims – Regional Salamander Equipment

Motion was made by Jefferson/Saline, seconded by Otoe to approve the funding request for the Southeast Region to purchase Command Ansi II Vests for the PET group in the amount of \$900.00 out of the FY2016 grant. Voting aye were Johnson/Pawnee, Richardson, Jefferson/Saline, Lancaster, Seward/York, Fillmore, Otoe and Gage; voting nay were none; Nemaha abstained. Motion passed.

Motion was made by Johnson/Pawnee, seconded by Fillmore to approve the funding request for the Southeast Region to purchase cache of ID/Credentialing Supplies such as cards, ID holders, and clips in the amount of \$1,530.00 out of the FY2016 grant. Voting aye were Gage, Otoe, Fillmore, Seward/York, Lancaster, Jefferson/Saline, Richardson and Johnson/Pawnee; voting nay were none; Nemaha abstained. Motion passed.
