The National Urban Areas Security Initiative Conference, Inc., in cooperation with The Department of Homeland Security, Federal Emergency Management Agency, Grant Programs Directorate, is hosting its 5th annual conference in San Francisco June 20-23, 2011. The theme for the 2011 conference is "Enhancing Capabilities through Regional Collaboration". The conference will provide an opportunity for stakeholders from all areas of homeland security and emergency preparedness to gather together and exchange important information to make our country safer. The conference will include all grants under the Homeland Security Grant Program (HSGP).

During the conference, federal, state, tribal, and local leaders and practitioners will have the opportunity to meet and discuss the latest issues in the Homeland Security Grant Program as well as examine the latest innovations and best practices in all related program and mission areas.

Sharing and Collaboration

The conference will provide the opportunity for interaction and information exchange between participants through town hall, roundtable and panel discussions. Panels will include subject matter experts with real life experience, useful examples, and policy insights to share. Information will also be shared via the conference web site, to include post conference reports, downloads, and message boards for sharing plans and information on issues that affect all grantees and working groups.

Background

This conference was originally conceived of as an information sharing opportunity by the Charlotte and Southeast Florida Urban Areas who, along with other UASI programs, recognized a distinct need for an effective information sharing platform among UASI jurisdictions. The first conference was held in Dallas, Texas in 2005 and was supported by the Metropolitan Fire Chiefs Association. This conference was attended by fire chiefs and UASI administrative professionals, who recognized the need for greater information sharing. Based on this conference, participants concluded that a larger conference was needed to provide similar information sharing across all first responder disciplines from all Urban Areas. The 2007, 2008, 2009, and 2010 National Conferences grew exponentially to include all of the designated urban areas and representatives from critical homeland security disciplines. The conference offered panel discussions, “lessons learned” and cutting edge technology demonstrations for attendees.

The 2010 Conference, hosted by the New Orleans UASI, looked to further build upon this strong foundation by including the Metropolitan Medical Response System (MMRS), Port Security Grant Program (PSGP), and Transportation Security Grant Program (TSGP) participants. The inclusion of these programs provided for a greater opportunity to share best practices and lessons learned among the larger homeland security community. The exhibitors’ display area was significantly expanded to provide access to a broad array of homeland security products and services and offered an increased opportunity for attendees to speak with companies that create most up-to-date technology solutions.

The 2011 National UASI and Homeland Security Conference is the largest to date and builds on this legacy. The conference has been expanded to include all DHS/FEMA/GPD preparedness grant programs under the Homeland Security Grant Program and also includes FEMA’s Grant Programs Directorate’s After Action

Conference. The Grant Programs Directorate is hosting its one-day After Action Conference (AAC) on June 23, 2011, immediately following the 2011 National UASI and Homeland Security Conference. The purpose of the AAC is to solicit state, local, and tribal input and feedback on the status, direction, and performance of FEMA's emergency preparedness and homeland security grant programs. In addition, other DHS partners who work closely with GPD on developing and administering certain programs will participate in this conference.

- **Compromised Medical Systems: Innovative Solutions from Actual Incidents:** Three principal leaders of the May 2010 Nashville Flood and the February 2011 Tulsa Blizzard responses will discuss the medical system compromises that presented significant challenges to the healthcare infrastructure. Each jurisdiction implemented innovative solutions and coordinated the response to ensure patient care needs were accommodated throughout these extreme weather conditions. Modified protocols were developed to address the extraordinary circumstances, i.e., as prolonged power outages, altered ingress/egress routes, damaged facilities and limited resources, which impacted hospitals, emergency medical services (EMS), and dialysis centers. These local jurisdictions utilized MMRS to support and coordinate the healthcare infrastructure as necessary to ensure patients received timely treatment.
